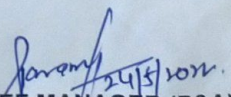

Subject:- Confirmation of Seniority list of Salesmen.

Vide Head Office letter No.HSDC/Estt./F-EA-III/2021/14360-61 dated 22.11.2021, a provisional inter-se-seniority of Salesmen was circulated for inviting objections, if any, from the concerned.
